Camp Standards:

New Life Island is a Christian Camp where we endeavor to explain and teach Biblical standards for Christian living. To avoid confusion during the camp season, the following summary of guidelines is given:

- Dress and behavior in keeping with a good Christian testimony will be expected at all times.
- Every camper must observe the daily schedule.
- No one is to leave the camp property without the permission of the Camp Director.
- Uncooperative or disruptive campers will be sent home. No refund will be given.
- Food and drinks are not allowed in cabins.

What to bring:

Bible, notebook, sleeping bag or bedding, pillow, toilet articles, old clothes, modest shorts and swimsuit, extra sneakers or sandals for river activities. Optional Items include: musical instrument, fishing pole, bug repellent, money for snacks, crafts, campstore, and offering.

What not to bring:

Cell phones, radios, ipods, or other personal listening devices, electronic games, tobacco products, alcoholic beverages, fireworks, knives, etc.

When to Arrive and Depart:

Campers should arrive between 9:00 and 10:00 am on Monday. Registration begins at 9:00 am.

We will have a short closing program after breakfast on Saturday. The program will include songs from the week and a video presentation. Normally, campers are ready to go at 9:30 am. The person(s) picking up your child must be approved by you and must sign for your child to be released. Special arrangements can be made through the camp office.

Notes to Parents:

1. All medications must be brought in their original container.
2. Please mark all clothing with camper's name.
3. All lost and found will be disposed of after the camp season.
4. The camp is not responsible for personal property which is lost or damaged.
5. Campers are not allowed to use camp phones.
6. Please do not send e-mail to campers.

While your child is away:

Enjoy the quiet and pray for your camper. Prayer will make a significant impact on your child's week of camp. Pray for your child's counselor and the speaker for the week. Pray for your child's spiritual needs and for social, physical, and emotional growth.

When your child comes home:

Ask about the week and then listen. Your interest in his week of camp is important. Ask about decisions and spiritual lessons. You can play an important role in reinforcing decisions made and lessons learned at camp.
